

RESOLUTION NO. 717

**BOROUGH OF MALVERN
CHESTER COUNTY, PENNSYLVANIA**

A Resolution of the Borough Council of the Borough of Malvern, Chester County, Commonwealth of Pennsylvania, adopting the Act 537 Supplement for the Wilson Road Force Main.

WHEREAS, Section 5 of the Act of January 24, 1966, P.L. 1535, No. 537, known as the "Pennsylvania Sewage Facilities Act" as amended, and the Rules and Regulations of the Pennsylvania Department of Environmental Protection (the "Department") adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, required the municipality to adopt an Official Sewage Facilities Plan, providing for sewage services adequate to prevent contamination of water and/or environmental health hazards with sewage wastes, and to revise said plan whenever it is necessary to meet the sewage disposal needs of the municipality; and

WHEREAS, Tredyffrin Township has prepared a "Act 537 Supplement for Wilson Road Force Main" dated July 2016, which provides for sewage facilities serving a portion of the Borough of Malvern; and

WHEREAS, the plan supplement was developed to evaluate the capacity of the force main and its ability to convey future flows after the force main rehabilitation is complete. Sewage flows for each Partner community served by the Wilson Road Force Main ("WRFM") were projected for a 25 year planning horizon (i.e., to the year 2040) for the purposes of evaluating the long-term capacity of the rehabilitated force main. Upon completion of the rehabilitation, anticipated in October 2016, the capacity of force main will be approximately 28 MGD. The total peak flow from the Partners served by the force main was projected to be 21.3 MGD in the year 2040. This indicates that the WRFM will have sufficient capacity to and beyond the planning horizon of the wastewater flow projections developed for the Act 537 Plan Supplement; and


WHEREAS, the Borough of Malvern finds that the Facility Plan described above conforms to applicable zoning, subdivision, other municipal ordinances, and plans, and to the comprehensive program of pollution control and water quality management.

NOW, THEREFORE, BE IT RESOLVED, that the Borough Council of the Borough of Malvern, hereby adopt and submit to the Department of Environmental Protection for its approval as a revision to the "Official Plan" of the municipality, the above reference Facility Plan. The municipality hereby assures the Department of the complete and timely implementation of the said plan as required by law (Section 5, Pennsylvania Sewage Facilities Act, as amended).




