A RESOLUTION ON NAMING THE THIRD FLOOR ROOMS IN THE BOROUGH OF MALVERN MUNICIPAL BUILDING FOR NORMAN H. HEINTZELMAN, JOSIAH HIBBERD, GEORGE N. HIGHLEY, AND FRED H. THOMAS

WHEREAS, Norman H. Heintzelman career spanned from the Malvern School System as a social studies and music teacher, to later becoming the assistant principal of the Tredyffrin-Easttown School System; and

WHEREAS, Norman H. Heintzelman was dedicated to serving the youth of the area and did everything in his power to keep Malvern's youth on the straight and narrow; and

WHEREAS, Josiah Hibberd left his mark on The Malvern Borough with his forty-year teaching career at the Malvern Elementary School, Sugartown Elementary School, and General Wayne Middle School; and

WHEREAS, Josiah Hibberd is remembered by former students for his excellent field trips, numbering in the thousands, and his involvement with local sports programs; and

WHEREAS, George N. Highley was a lifelong resident of Malvern Borough, best-known as a descendant of the first settlers to Malvern and was the president of the family-founded National Bank of Malvern;

WHEREAS, George N. Highley was a historian and genealogist, with a great interest in history, he wrote and published *The History of Malvern*, in 1964, which delved into the history of the Borough; and

WHEREAS, George N. Highley served as the Chester County Historical Society's president, served as the Justice of the Peace, as treasurer of The Paoli Memorial Association, and sat on Borough Council; and

WHEREAS, Fred H. Thomas was a well-loved Mayor of Malvern, serving three terms from 1965 to 1977; and

WHEREAS, Fred H. Thomas was a member of the Malvern Volunteer Fire Company, a member and a past-president of Borough Council, and a member, vice-president, and president of the Malvern Board of Education; and

WHEREAS, Fred H. Thomas was nicknamed "Mr. Malvern" for dedicating his life to the Borough of Malvern; and

NOW, THEREFORE BE IT RESOLVED that, as an enduring tribute to Norman H. Heintzelman, the small conference room located on the third floor of Borough Hall will be named the Norman H. Heintzelman Meeting Room; and

NOW, THEREFORE BE IT RESOLVED that, as an enduring tribute to Josiah Hibberd, the large meeting room located on the third floor of Borough Hall will be named the Josiah Hibberd Meeting Room; and

NOW, THEREFORE BE IT RESOLVED that, as an enduring tribute to George N. Highley, the History Center room located on the third floor of Borough Hall will be named the George N. Highley Historical Commission Office; and




