#### b. SURFIN' USA EVENT – MBPA SPONSORED

<u>MOTION:</u> To authorize the MBPA, Dressler Estate Cider, Locust Lane Beer, and PA Distilling Spirits to utilize the municipal lot for a beer/ wine garden, adjacent to Wolfe's Brass, for the "SURFIN' USA" event scheduled for Saturday, May 6, 2023, pursuant to the Borough Solicitor's conditions and approval by the Pennsylvania Liquor Control Board, as well as pay for the Malvern Borough Police detail associated with this event from the American Rescue Act funds.

The MBPA is hosting the "SURFIN' USA" event on Saturday, May 6, 2023 and is requesting approval to have alcoholic drinks available for purchase in the municipal lot adjacent to Wolfe's Brass. The providers will be Dressler Estate Cider, Locust Lane Beer, and PA Distilling Spirits. Additionally, Borough Council will be discussing if the Malvern Borough Police detail associated with this event will be paid from the American Rescue Act Funds.

#### c. BID AWARD FOR HIGHLAND AVENUE & KING STREET

**MOTION:** To authorize Jena Asphalt Solutions, Inc. of Spring City to complete the Highland Avenue and King Street paving project in the amount of \$88,723.95.

Jena Asphalt Solutions, Inc. of Spring City, PA, was the low bidder and has submitted the necessary documents including the Bid Bond, Anti-Collusion Affidavit, Workmen's Compensation Act Affidavit and the Public Works Employment Verification Form. The Borough Engineer has reviewed the submitted bid documentation and found it to be adequate. The Borough Engineer recommends the project be awarded to Jena Asphalt Solutions, Inc. in the amount of Forty Thousand dollars and 00/100 cents (\$40,000.00). Please note, the estimated material costs for this project will be approximately \$48,723.95 for a total project cost of \$88,723.95. \$139,059 is currently budgeted to complete these road improvements.

Mrs. Jennifer Chomko commented on Quann Park and inquired about the recent improvements made to the Park.

The Public Safety Sub-Committee has not met since the last Borough Council meeting and is scheduled to meet on March 27, 2023.

#### 5. SPECIAL BUSINESS

#### a. REGIONAL FIRE STUDY

Council President Finkbiner explained that East Whiteland and Charlestown Townships, including their Fire Companies, have invited Malvern Borough and Malvern Fire Company to participate in a Regional Fire Study. The Malvern Fire Company Board agreed and voted upon participating in this study at their Monday, March 13, 2023 board meeting.

Borough Council discussed this matter and is in support.

Mr. John Buckley commented and inquired if there was any cost for having the study completed.

Borough Manager Loomis clarified that there is not cost for the study to be completed.

A motion was made by Council Member Laney, seconded by Council Member Frederick, and carried by a vote of 7-0, to authorize a Regional Fire Study application submission to the Department of Community and

Economic Development in cooperation with East Whiteland and Charlestown Townships.

#### 6. <u>UNFINISHED BUSINESS</u>

#### a. TRASH BID FOR YEARS 2023 & 2024

Council President Finkbiner explained that the trash contract concludes with A.J. Blosenski as of June 30, 2023. New rates are anticipated to be substantially higher due to inflation. The Borough must solicit bids for a new provider and may specify multiple service options in order to compare pricing. Potential service options include reducing collection to one day per week, requiring residents to use bins provided by the trash company, and/or revering bulk trash pickup to twice per year. The Finance and Administration Sub-Committee met on March 8, 2023 suggesting obtaining a price for services as they currently exist, as well as service pick up for 1 day a week with trash bins provided by the trash company. The F&A Sub-Committee also suggested the initial contract be for 18 months in order to align the trash contract with the budget cycle.

Borough Council discussed the various bid options to be distributed.

Mr. Joe Rubino, Mrs. Jennifer Chomko, and Mr. John Buckley commented on the Borough's trash services.

Mr. Hugo Schmitt commented that Waste Connections bought A.J. Bloskenski.

Mrs. Sid Baglini commented on composting program referencing Radnor Township.

A motion was made by Council Member Laney, seconded by Council Member Frederick, and carried by a vote of 7-0, to authorize the trash contract be bid for the same services currently offered, for the same services offered with uniform trash bins provided by the trash company, and collection once a week without uniform trash bins, having bulk pick up occur semi-annually. The initial contract term shall be 18 months, with one or two 12-month option periods.

#### a. ZONING HEARING BOARD

Council President Finkbiner explained that there are no new Zoning Hearing Board applications before the Zoning Hearing Board.

#### 7. NEW BUSINESS

### a. NATIONAL WILDLIFE FEDERATIONS'S MAYOR'S MONARCH PLEDGE

Mayor Uzman gave a presentation on the National Wildlife Federation's Mayor's Monarch pledge, a national coalition of mayors and heads of local and tribal governments recognized across the U.S. for their efforts to sustain the monarch butterfly population for generations to come. The Mayors' Monarch Pledge is currently accepting pledges until March 31, 2023. He explained that action items are required to be submitted to initiate the pledge.

Dr. Helise Bichefsky, DO is in support of the Mayor's Monarch Pledge.

Mrs. Jennifer Chomko is in support of the Mayor's Monarch Pledge and offered to have the children partake in the project.

Mrs. Sid Baglini is in favor of the project and offered an informative background and education on butterflies regarding their benefit to the environment.

Mr. John Buckley commented on the food source for the butterflies and areas that would support such.

#### 8. PUBLIC FORUM

Dr. Helise Bichefsky, DO invited the public to the Egg Hunt hosted by the Parks and Recreation Committee.

Mrs. Jennifer Chomko thanked the Borough for contacting St. Patrick's Church to address the dismissal safety issue. She requested that enclosures and/or different dog waste bins be placed on Second Avenue. The Borough Manager will look into this matter.

Borough Manager Loomis thanked Assistant Manager Badman for her time and effort in installing the new sound system that was used this evening.

Chief Marcelli thanked Gina Jones for her efforts in obtaining a \$20,000 document retention grant for the Malvern Borough Police Department.

### BOROUGH OF MALVERN CHESTER COUNTY, PENNSYLVANIA

#### **ORDINANCE NO. 2023-01**

AN ORDINANCE OF THE BOROUGH OF MALVERN, CHESTER COUNTY, PENNSYLVANIA, AMENDING CHAPTER 25, SECTION 25-29, OF THE CODE OF ORDINANCES OF THE BOROUGH OF MALVERN, PENNSYLVANIA, BEING THE ADMINISTRATIVE CODE, PROVIDING FOR AN ALTERNATE MEMBER FOR THE ENVIRONMENTAL ADVISORY COUNCIL.

**WHEREAS**, the Borough of Malvern (the "Borough") is a borough located within the Commonwealth of Pennsylvania governed by its duly enacted Home Rule Charter, as amended; and

**WHEREAS**, the Borough has established an Environmental Advisory Council to provide guidance and support to Borough Council; and

**WHEREAS**, Borough Council deems it to be in the best interests of the Borough to provide for an alternate member for the Environmental Advisory Council.

## NOW, THEREFORE, IT IS HEREBY ORDAINED AND ENACTED BY THE BOROUGH OF MALVERN AS FOLLOWS:

<u>Section 1. Amendment to Section 25-29.</u> Chapter 25, Section 25-29. N (1) of the Code of Ordinances of the Borough of Malvern, Pennsylvania, being the **Administrative Code**, **Advisory commissions and committees**, is hereby deleted in its entirety and amended to state the following:

- (1) (a) The Environmental Advisory Council shall be composed of seven (7) members and one alternate member. The members shall be residents of the Borough; serve without compensation; and be appointed by the Borough Council as follows: two (2) members for a term of two (2) years; two (2) members for a term of three (3) years; and three (3) members for a term of four (4) years. On the expiration of the term of any member of the Environmental Advisory Council, his/her/their successor(s) shall be appointed by the Borough Council to serve for a term of three (3) years.
  - (b) Borough Council may appoint one (1) alternate member of the Environmental Advisory Council. The alternate member shall be a resident of the Borough and serve without compensation. The term of office for the initial alternate member shall expire December 31, 2025, and, upon expiration of the initial term, the alternate member shall be appointed to serve for a term of three (3) years. When seated, an alternate member shall be entitled to participate in all proceedings and discussions of the Environmental Advisory Council to the same and full extent as provided by law for the Environmental Advisory Council members, including, specifically, the right to cast a vote as a voting member during the proceedings.

**Section 2.** This Ordinance shall become effective five (5) days from enactment.
