3. Unfinished Business
  - a. King Street Tree Planting Project
    - As of 4/27/22 eight residents have responded to the Administration letter regarding the planting of trees. Five residents are in favor of planting trees and three are not. Ten residents/businesses' have not responded. The Borough Engineer advised that the trees are being planted are on private property and the Borough may not mandate or require the non-responses to have trees planted.
    - Discussion on how best to approach the property owners who have not responded.
  - b. Paoli Battlefield
    - Native shrubs to be planted in Fall to enhance natural buffer
  - c. Second Avenue - PECO - updating utilities —32 trees to be removed
    - Status of summary sent to PECO requesting 10 trees be saved
  - d. Site Visits
    - Warren Avenue near Paoli Pike - tree removal. Bill Wilfong to report on site and easement
    - 311 E Broad Street - Permit to remove tree denied, as written, by STC review letter sent by owner
    - Ira Dutter, Public Works requested STC assess a tree with bark falling off on King St.
    - STC will select trees for pruning at Rubino Park and Paoli Battlefield. The date will be determined this Spring as to when the pruning occurs.
  - e. Tree Replacement pursuant to SALDO
    - Follow up on tree replacements on Monument, First, and Church Avenues
    - Follow up on trees to be planted on Ruthland Ave

  - a. Review Subdivision & Land Development Plan located at 551 Sugartown Rd - 2 lot subdivision
5. Spring Bare Root Trees
  - 24 trees were picked up by Public works and delivered to residents. Joe Bones and Dave Burton planted a Swamp White Oak at Powelton and First Avenue (Quann Park) and a Crabapple tree at Herzak Park, Bridge St. and Old Lincoln Highway.
