4. NEW BUSINESS:

a) 11 Griffith- SALDO- Review #1

Renehan presented plans for 11 Griffith Ave. The plans show the property being subdivided into two lots with two single family homes build, one on each lot.

Dave Knies went through the review letter from Dan Daley, date March 19th 2019. Items discussed, included: 1) Area and Bulk Regulations, 2) Cartway width, 3) Driveway, 4) Sidewalks, 5) Stormwater Management, and 6) Landscaping.

Due to a number of issues that need to be fixed, the Commission recommended that Renehan Builders fix the issues and return to present the updated plans at a future meeting.

b) Historical Ordinance #2015-15

c) Comprehensive Plan Update
