### 3. UNFINISHED BUSINESS

Zoning & Subdivision and Land Development Ordinance Amendments

• Street Tree and Plant Materials List

Chairman Carroll Sinquett re-introduced the Street Tree Ordinance Amendments. There were changes made to the text therefore the Planning Commission needs to give their final recommendations to Borough Council.

Mr. Ken Kynett, Esq. gave an in-depth explanation in line with the May 20, 2021 meeting stating that the plant materials is currently included as an appendix. The current list can be adopted with the ordinance changes and that list can be easily and quickly afterward. Amending from time to time by resolution avoids a cumbersome ordinance amendment process moving forward.

The Planning Commission members discussed in detail native versus non-native species. Dr. Zoe Warner, Ph.D. and Mr. Scott Oswald are in favor of including only native species while the remaining members are in favor of including both on the list and moving forward with the list as it currently stands with the list being amended by resolution.

Mr. Geoff Rubino recommended that the Borough and Planning Commission utilize the information provided by Dr. Zoe Warner, Ph.D. regarding USDA Forest Services contact for tree and plant list recommendations.
