News from Malvern Borough Council

Like the rest of the country, Malvern Borough continues to address issues related to the COVID-19 pandemic. The Borough continues to follow the guidelines issued by the Centers for Disease Control and Prevention, the Chester County Health Department, and the PA Department of Health. On June 26, 2020, Chester County was moved into the green phase of Governor Wolf's economic re-opening plan. The Borough has prepared guidance documents for residents and businesses for the green phase that are available on the Borough website. COVID-19 cases in the Borough continue to remain low and no deaths have been reported; however, we urge all residents to continue following the guidelines issued in order to combat the spread of COVID-19. This includes regularly washing your hands with soap and water for at least 20 seconds, wearing a mask when in public, limiting non-essential travel, and staying home if you are sick. Borough Council and the various volunteer boards and committees will continue to hold virtual meetings. Information on how to participate virtually is updated regularly on the Borough website.

On June 16, 2020, Borough Council adopted

Ordinance No. 2020-5, which provided several amendments to the Borough's Zoning Ordinance. These amendments addressed area and bulk requirements, such as building coverage and side yard setbacks, in the Borough's residential zoning districts. Completion of this ordinance involved the professional guidance of the Brandywine Conservancy. We would also like to thank the Planning Commission for their diligent review.

Borough Council is also pleased to be in the beginning phases of the update to the Borough's Comprehensive Plan. The last update was completed in 2012. On April 8, 2020, the Borough learned that we have been awarded a \$31,890 Vision Partnership Program grant from the Chester County Planning Commission in order to complete this project. The planned completion timeline is approximately two (2) years. On July 7, 2020, Borough Council appointed the Brandywine Conservancy to oversee the completion of this project. A taskforce from the community will also be established. Please watch the Borough website for additional information.

There are several projects underway in the Borough that will continue through this summer. On May 20, 2020, the N. War-

ren Ave. Transit Project resumed construction. Substantially funded through \$560,000 in grant funding, this has been a long-planned project and we are happy to have it completed this summer. Borough Council also awarded two (2) paving projects. These paving projects will occur on E. King St. (from Bridge St. to Warren Ave.) and on N. Warren Ave. (from Pennsylvania Ave. to the Borough boundary with East Whiteland Township). Please watch the Borough website for information on these projects.

Borough Council consists of Amy Finkbiner, Ph.D. (Council President), Jamie Grossman (Vice-President), Joe Bones, Marty Laney, John Meisel, Brendan Phillips, and Julie Raynor. Meetings of Borough Council are held at 7:30 pm on the first and third Tuesday of each month at Borough Hall. All are welcome and encouraged to attend. As always, if you have any questions about anything going on in town, contact any member of Borough Council, the Mayor, or the Borough Manager. Information is updated regularly on the Borough website at www.malvern.org and emergency notifications are sent through the ReadyNotify system.

Board & Commission Vacancies

Below is a list of vacancies on the Borough's boards and committees.

- **Zoning Hearing Board:** There is currently one (1) vacancy on this Board for an alternate member of the Zoning Hearing Board. This position carries a three (3) year term. The individual appointed will complete a term that expires on January 1, 2021. Alternate members attend all meetings of the Zoning Hearing Board; however, they do not vote unless a voting member is absent or can otherwise not participate in the hearing.
- **Planning Commission:** There are currently two (2) vacancies on the Malvern Borough Planning

Commission.

- ⇒ **Regular Voting Member:** This vacancy is for a full, regular voting member. This position carries a four (4) year term. The individual appointed to this position will complete a term that expires on January 1, 2021.
- ⇒ **Alternate Member:** This vacancy is for an alternate member and the position carries a four (4) year term. As an alternate member to the Planning Commission, this



individual appointed will be permitted to participate in all meetings and discussion, but would not vote unless designated to do so by the Chair. This would include instances where a member is either absent, has recused themselves from a topic of discussion, or is disqualified by the governing body.

Storm Water Management

Untreated or uncontrolled storm water runoff is the number one cause of impairment in our local waterways. Polluted runoff is often transported through municipal drainage systems until it eventually discharges into streams, ponds, and rivers untreated.

Malvern Borough is committed to improving water quality through better management of storm water runoff. Every resident can participate in our stormwater program by reducing or preventing pollutant runoff from their own

property and by reporting any non-storm water discharges into the Township's drainage system and local streams.

What can we do to help keep waterways clean? There are numerous things we can all do on a daily basis to keep pollution out of our waterways. The following are just a few things we can all do to help improve water quality in our streams, rivers and lakes:

- Never dump anything into storm drains, swales or streams.

- Pick up litter from the street before it gets into storm drains.
- Use limited amounts of fertilizer.
- If you must use pesticides, search for an environment-friendly brand.
- Recycle motor oil, paint, and other hazardous chemicals. Never dump such materials down the drain or into the storm system.
- Recycle glass, plastic, and aluminum.
- Always pick up your pet's waste or harmful bacteria can get into our water!

Codes Enforcement Officer

As the hedges, bushes and flowers grow along the sidewalk at your property, please make sure that they don't spread to the point where they obstruct the sidewalk. This makes it difficult, not to mention dangerous, for pedestrians who use the sidewalks. In light of Malvern Borough's size, many people, residents and non-residents alike, use the sidewalks to get around. In addition, where vegetation is

planted near road intersections, it's important to keep them trimmed back so they don't become a sight hazard to motorists trying to go through those intersections.

Speaking of sidewalks, residents and businesses are required to maintain their sidewalks in good repair and free from trip hazards. While out trimming the vegetation along the sidewalk, take a look at the condition of the sidewalk sections for cracks and broken sec-

tions. If a section of the concrete (including along cracked areas) is about a half inch higher than the section next to it, a pedestrian could well trip and fall and hurt themselves. These areas need to be repaired or replaced in order to keep the sidewalks safe.

• **Litter Patrol** - Show us how you can keep our streets, parks, and open spaces clean by **picking up and disposing of 1 piece of trash daily**. Then think about taking it to the next step--make sure that that piece of trash gets in the appropriate receptacle. Is it

recyclable, or does it go to the landfill? Show us a picture of yourself cleaning up, and tell us about your trek. What was the craziest thing you found? Did you have to go out of your way to find something? Did you learn a little more about recycling? And, of course, always use caution and safety when picking up any trash.

• **Sipping Sustainably** - Make a promise **not to use a plastic straw**. Plastic straws are one of the most widely used single-use plastics products. Straws are energy-intensive to produce but are too small to be recycled. They are not biodegradable and don't break down naturally. Straws often end up in our waterways, which harms turtles and other wildlife when they ingest them. Think about the sea life you're helping when you take this challenge, and snap a photo of the most unusual drink you had without a plastic straw. Let us know how you managed over the 30 days and whether you convinced others to skip the straw.

• **Idle No More** - Help the drivers in your family to improve our air quality by **turning the car off when idling**. Exhaust emitted into the atmosphere from idling vehicles poses real health risks such as respiratory problems, asthma, and allergies. Carbon dioxide emissions from car exhaust also contribute to climate change. But turning off the engine saves gas, which means more money in your pocket. So shut that engine off when waiting for take-out or curbside pickup, when waiting in a pickup/drop-off line, or when taking a phone call or lunch break. Where was the most unusual place you were idle without idling? Tell us whether you become more aware of others idling.

With these individual actions, we can witness the power of change, form new habits, and help make Malvern a healthier and a more environmentally sustainable community. Let's get ready to make a difference!

Randolph Woods Master Plan

The Randolph Woods Master Plan Committee is continuing to work on developing its Master Plan recommendation to Borough Council for the Randolph Woods Nature Preserve. Two (2) public meetings

were held virtually on May 6, 2020 and June 24, 2020 due to the COVID-19 pandemic. Notes and presentation materials from these meetings are available on the Borough's website. We are very appreciative for the hard work and dedication of the members of the Committee and representatives from Simone-Collins. The Willistown Conservation Trust has also been an important partner in this endeavor and we are very appreciative of their support.

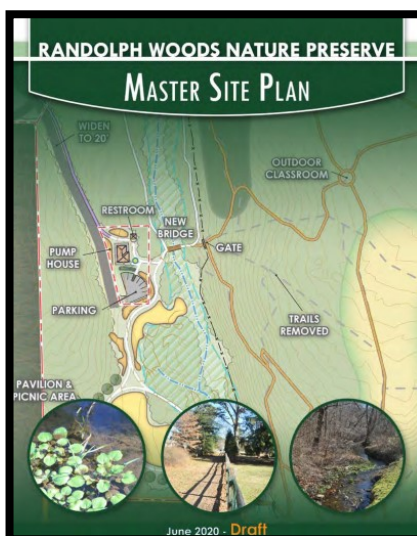
Through the work with Simone-Collins Landscape Architects, a draft plan has been developed. This plan includes some significant improvements to the nature preserve, including the following:

- The addition of ADA trails and bridges.
- A potential boardwalk along Ruth's Run.

- Construction of a pavilion and a natural play area for children.
- Improvements to the walking trails.
- Improvements to the condition of the forest by restricting deer.
- Reducing invasive species and better water shed management.

The Master Plan is targeted for Borough Council review in September. A draft of the Master Plan is available for public review on the Borough website.

Malvern Planning Commission

The Malvern Planning Commission (MPC) is a 'review and recommend' body of seven Borough residents that examine Subdivision and Land Use (SALDO) applications, Zoning Hearing Board (ZHB) applications, monitor Zoning Ordinances, undertake Planning Initiatives, and provide comments on other Community Planning matters referred by Borough Council. The MPC's planning efforts are supported by the Assistant Borough Manager, Borough Engineers, and Borough Solicitors.

Over the course of the last few months, the MPC has primarily focused on the review and recommendation of pending applications before the Zoning Hearing Board. The following applications have been reviewed by the MPC:

- **418 E. King St. – JHT, LLC:** This is the site of a former auto repair

facility being converted into an office. The application sought relief from the Borough's Zoning Ordinance for parking requirements. The application was ultimately withdrawn as an agreement was reached with a neighboring property for dedicated parking that completed with the Borough's Zoning Ordinance.

- **128-142 E. King St. – ZMC Partners, L.P.:** This is currently a vacant lot at the corner of Bridge St. and King St. An office building is being proposed for this site. The applicant is seeking relief for building height, parking requirements, raised planting islands in the proposed parking area, and to have a buffer less than 20 ft. as required.

Current MPC members include Dave Knies, Chris Mongeau,

Mark Niemiec, Geoff Rubino, Carroll Sinquett III (Chairperson), and Zoe Warner (Vice-Chairperson). We continue to seek two additional Commissioners: a regular voting and an alternate member. Tiffany Loomis, Assistant Borough Manager/Zoning Officer, serves as the Secretary for the Planning Commission and Kenneth Kynett, Esq. of the firm Petrikin Wellman Damico Brown & Petrosa serves as the Planning Commission Solicitor.

The Malvern Planning Commission meets on the first and third Thursdays of each month, 7:30 PM at Borough Hall. Public participation is welcomed and encouraged! The status of various SALDO applications and initiatives can be viewed on the Borough website under Boards and Commissions/Planning Commission/Case Log.

Malvern Historical Commission

"No Monday Afternoon Club meetings were held in October 1918 'on account of the quarantine for influenza.'" (Malvern Treasures, Nancy B. Schmitt). It seems that history repeats itself, with meetings for the Historical Commission and other commissions and civic groups being postponed or canceled during 2020. This does not mean that we are not still focused on preserving both our past and the present for future generations.

So far in 2020, your Historical Commissioners have enjoyed our annual training opportunity from the Chester County Historic Preservation Network at the Brandywine River Museum on March 7. Seminar topics included historic integrity, as defined by the National Park Service. We were all very grateful to have attended this year's session before the pandemic shut things down.

Our June meeting resulted in our choosing our 2020 Preservation Awardees. We are cautiously optimistic we will have a chance to present these plaques soon. Please

keep an eye on the Borough Council agendas and our social media (Facebook and Instagram are @MalvernBoroHistory). One of our last walks as a Commission was on Sunday, May 31 (see photo). The astute among you may recognize that date as what should have been the 152nd Memorial Parade. Four of our Commissioners were joined by Fran and Cathy Givnish as we upheld the tradition to march the Sunday after Memorial Day to honor fallen soldiers. Our route reversed the original marches of the late 1800s,

walking from the Malvern Baptist graveyard westward on Monument to the Paoli Memorial Grounds and Monument Park. Officer Bury from the Malvern Borough Police escorted the paraders from Monument Ave to the flagpole at the top of the horseshoe, where we sang the National Anthem to the dozen or so persons enjoying the afternoon at the park. The official Memorial Parade, at the time of publication, was rescheduled for Sunday, September 20, 2020, at 1:30pm.

We invite all Malvernites to reach out to the commission with any requests or suggestions, but please be patient as our access to our archives in Borough Hall remains limited. Our Facebook and Instagram posts are also both great ways to engage with us and with our community.



Malvern Police Department

We have experienced unprecedented times over the past few months in the Malvern community and around the world. We have been dealing with a pandemic, quarantine, social unrest, riots and more.

First, the COVID-19 pandemic was a sudden shift in our societal norms and made all of us more in tune with our health practices and safety. COVID-19 presented the Police Department with many challenges. While still maintaining a quality level of service to the public, we needed to make sure our officers and their families were protected. I wrote new policies to ensure safe practices. Officers were issued personal protective equipment and shifts were staggered so the officers would not be together at the station. Calls were handled over the phone when possible to avoid unnecessary contact, public access to the police department was suspended and the cleaning of our work areas, including our vehicles, became a daily activity. All of these changes happened behind the scenes so the residents we serve were provided with a seamless transition to this "new normal."



Due to the prolonged closure and the cancelling of many activities, we wanted to do something for our community to boost their spirits. We initiated "Celebration

Parades" for anyone who had a birthday, anniversary, or any special occasion. Malvern Police, in conjunction with the Malvern Fire Company and Willistown Police, coordinated with our residents to schedule drive by parades for their families to help with their celebrations. Seeing the smiles on kids' and adults' faces benefitted everyone. We scheduled a Class of 2020 "Graduation Parade," which included almost every street in the Borough. Surrounding agencies participated, which included Willistown and East Whiteland Police, as well as Malvern and East Whiteland Fire Companies. Bob Kelly from Fox29 News rode along doing a Facebook Live taping. It was a great day and we are glad to have been a part of your celebrations.

We are extremely thankful to our residents and businesses for your support and kind donations of items, such as masks, hand sanitizer, gloves, and other personal protective equipment. Our community came out in full force to support first responders during this unprecedented time. We had a job to do and we wanted our residents and businesses to know, no matter what, we would be there for you. I wish I could say this was the most difficult time we would face, but sadly, it was not. People across the country and around the world witnessed the horrific actions, which occurred on May 25, in Minneapolis, MN, involving the death of George Floyd. Malvern Police Officers joined me along with other departments condemning those actions. We witnessed many peaceful protests, but also violence, riots, and looting all over our

great country. As law enforcement across the nation came under scrutiny, Mayor Burton and I reviewed our policies and confirmed we comply with the "8 Can't Wait" Campaign. We worked together with local activists to plan a peaceful protest for Black Lives Matters and provided them with security during their rally. I participate in virtual town hall meetings with advocates for race equality; these meetings create dialogue for us to understand better the needs of our society and discuss ways to enhance our relationship.

As Chief of Police, I am committed to listening to the community. The Malvern Police Department takes pride in being professional and providing superior police service to all people, regardless of gender, race, religion, nationality, or sexual orientation. Malvern Police will continue to provide our services without bias.

Malvern Officers will attend available diversity training to continue to learn and grow.

We at the police department have seen firsthand our community at its best and we encourage you all to continue to let Malvern be the place where everyone is welcome to live, work and raise their family.

Thank you for letting us be a part of it all.

Real Estate Tax Payment Deadlines Extended

On April 21, 2020, Borough Council adopted Resolution No. 810. In accordance with Act No. 15 of 2020, this Resolution extended the payment deadlines for the Borough's real estate tax payments. The new payment deadlines are below:

- **Discount period** – Payment during the discount period outlined on your Real Estate Tax bill is extended until **August 31, 2020**.
- **Face period** – Payment during the face period outlined on your Real Estate Tax bill is extended until **December 31, 2020**.

Property owners are encouraged to make tax payments through the mail or by placing payments in an envelope in the dropbox located on the exterior of Borough Hall. The dropbox is secure and being checked daily.

Malvern Shade Tree Commission

The Borough's Spring bare root tree planting was cancelled due to Coronavirus. However, the Pennsylvania Horticultural Society has contacted us and they are hopeful, and moving forward, to have trees available for Fall planting. If this takes place, those residents on the Spring 2020 list will receive a tree this Fall and we will carry over the waiting list until next spring.

Please refer to the Shade Tree Ordinance when planting or contemplating removal of street trees on your property. For instance, if you are considering the

removal of a street tree within the Borough's right-of-way, a permit is required, because by law, such trees are considered public amenities. No permit is required for trees on your property if they are not in the right-of-way. If in doubt, please contact the Borough. If planting trees, please call 811 prior to planting so utility lines can be marked and avoided during the planting process.

A series of June storms brought unusually high winds that caused a significant amount of damage to Malvern's trees. If you are concerned about a tree on your

property, before having it removed we suggest you first have it inspected by a certified arborist to determine its condition. Malvern has a number of large shade trees that contribute to the health and beauty of our community. A certified arborist can help you determine if your tree represents a risk or is a treasured asset to your home and community.

Paoli Memorial Association

PMA is the non-profit organization which owns the grounds along Monument Avenue from Wayne Avenue to Sugartown Road. This includes the grave site where 52 American soldiers are buried following the Battle of Paoli in 1777, the surrounding grounds, Monuments and road, the park and tennis courts which are maintained by the Malvern Park & Civic Association, the two baseball fields maintained by the Little League

and the Boy Scout Cabin maintained by the Cub and Boy Scouts. The mission of the PMA is to preserve all the grounds for the use and enjoyment of the residents and to memorialize the soldiers buried there. As mentioned, the PMA has a responsibility to maintain these grounds but needs funds in order to do so. The Borough of Malvern has opened the entire Historical Park to the public, not just the walking trails. Keep in mind that it is an open, passive, park and there are no on-site Malvern Borough, Paoli Battlefield Preservation Fund or Paoli Memorial Association personnel present. Please use common sense when at bulletin boards, interpretive panels, monuments, exhibits and the sole free-standing portable toilet. They have surfaces that might be compromised. There is no running water at the Battlefield Park.

PBPF has cancelled a number of events over the summer, including our lecture and entertainment at the General Warren. We have also cancelled our popular Annual Heritage Day in September. Instead of our full day event with scores of organizations, exhibits, activities, music and food trucks, we are partnering with the Malvern Memorial Parade.

The Malvern Memorial Parade has rescheduled to Sunday, September 20, 2020, after

which we will stage a skirmish between British Light Infantry and American Continental soldiers. The Battle of Paoli was the ninth bloodiest encounter in the Revolutionary War. The Memorial Parade is the oldest, continuously held parade specifically honoring American fighting forces. And prior to Decoration Day/Memorial Day started after the Civil War, annual parades were held starting 1817 as Paoli Day to honor those who are buried here. Please support this unique historical event.

We are looking into using Zoom for our popular monthly Lectures in the Fall and checking if the speakers can participate. More on this later! Like many other organizations, we have been holding Board Meetings via internet conferencing.
