# News from Borough Council

The Borough had a very productive year in 2019. We completed major projects (most notably, the upgrade to the Ruthland Avenue force main). established an Environmental Advisory Council, received a \$10,000 grant from PECO to complete a master plan for Randolph Woods, installed new pedestrian crossing signals on King Street, and saw new volunteers join our boards and committees. Looking forward, we are excited for what 2020 has to offer.

We would like to extend a thank you to Zeyn Uzman and Carroll Sinquett for their service on Borough Council over the last four (4) years. They both brought considerable knowledge that was greatly appreciated. Both will continue their service to the community on the Historical Commission and Planning Commission, respectively.


At the December 17, 2019 meeting, Borough Council approved the 2020 budget. We are pleased to report that the 2020 budget does not include any increase to taxes or sewer The 2020 budget rates. includes several major projects, including paving of Borough roads, completion of the sidewalk and traffic signal project on N. Warren Avenue, and the replacement of certain vehicles in the Public Works Department. In conjunction with

the 2020 budget, Borough Council also completed a review and update of the Borough's five-year Capital Improvement Plan. Development of this plan will assist the Borough in guiding future projects in the community. A copy of both the 2020 budget and the fiveyear Capital Improvement are available for review on the Borough website.

The N. Warren Avenue Transit Project is preparing to commence construction. Borough Council awarded this project to Road-Con, Inc. on September 3, 2019. This long-planned project is being substantially funded by a \$560,000 grant that the Borough received. The project involves the upgrade of the traffic signal at the intersection of Warren Avenue and King Street, as well as the installation of sidewalk from the northern train station parking lot to Pennsylvania Avenue. We are very pleased to have this project underway. Please watch the Borough website for information on the start of this project.

Borough Council consists of Amy Finkbiner, Ph.D. (Council President), Jamie Grossman (Vice-President), Joe Bones, Marty Laney, John Meisel, Brendan Phillips, and Julie Raynor. Meetings of Borough Council are held at 7:30 pm on the first and third Tuesday of each month at Borough Hall. All are welcome and encouraged to attend.

## **Board & Commission Vacancies**

Below is a list of vacancies on the Borough's boards and committees.

 Zoning Hearing Board: There is currently one (1) vacancy on this Board for an alternate member of the Zoning Hearing Board. This position carries a three (3) year term. The individual appointed will complete a term that expires on January 1, 2021. Alternate members attend all meetings of the Zoning Hearing Board; however, they do not vote unless a voting member is absent or can otherwise not participate in the hearing. •Planning Commission: There are currently two (2) vacancies on the

Malvern Borough Planning Commission.

⇒Regular Voting Member: This vacancy is for a full, regular voting member. This position carries a four (4) year term. The individual appointed to this position will complete a term that expires on January 1, 2021.

 $\Rightarrow$ Alternate Member: This vacancy is for an alternate member and the position carries a four (4) year term. As an alternate member to the Planning Commission, this individual appointed will be permitted to participate in all meetings and discussion, but would not vote unless designated to do so by the Chair. This would include instances where a member is either absent, has recused themselves from a topic of discussion, or is disqualified by the governing body.

•Parks & Recreation Committee: There is currently one (1) vacancy on the Malvern Borough Parks & Recreation Committee. This position carries a five (5) year term. The individual appointed will complete a term that expires on January 1, 2021.

Malvern residents who are interested in serving the Community on these committees may apply by sending a letter of interest and resume to the Borough Manager.

# Randolph Woods Master Plan

The Randolph Woods Nature Preserve is a 43 acre wooded park currently preserved under a conservation easement with the Willistown Conservation Trust. Randolph Woods is a critically important park in the Borough, offering various passive recreational opportunities to the community. The property was previously the main operations for the Borough's water system, with the original pump house still located on the Additionally, Ruth Run property. traverses the park and is an important part of the Crum Creek watershed. This small headwater stream is fed by a series of springs located within Randolph Woods, which protects approximately one quarter of a mile of Ruth Run. The protection of small headwater streams is vital to maintaining downstream water quality, and the high quality of Crum Creek is due, in part, to the high value of Ruth Run.

During 2017, Borough Council commissioned an ad hoc committee to make recommendations to study the future of the property, one of which was to develop a master plan. A copy of the report is available on the Borough website. In 2019, Malvern Borough was awarded a \$10,000 PECO Green Region Grant for the development of a Master Plan for the Randolph Woods Nature Preserve. Borough Council appointed a committee to guide the development of the master plan and appointed Simone-Collins Landscape Architects to prepare the plan document. In order to complete the plan, a series of public meetings will be held on the following dates

January 22, 2020 March 25, 2020 May 6, 2020 June 24, 2020

All meetings will be held at 7:00 pm at Malvern Borough Hall (1 E. First Avenue, Suite 3, Malvern, PA 19355). Additional information may be found on the Borough's website.

## Storm Water Management

Untreated or uncontrolled Stormwater runoff is the number one cause of impairment in our local waterways, runoff is often transported through municipal drainage systems until it eventually discharges into streams, ponds, and rivers untreated.

Malvern Borough is committed to improving water quality through better management of storm water runoff. Every resident can participate in our Stormwater program by reducing or preventing pollut-ant runoff from their own property and by reporting any nonstorm water discharges into the Borough's drainage system and local streams.

What can we do to help keep waterways clean? Never dump anything into storm drains, swales or streams.

•Pick up litter from the street before it gets into storm drains.

•Use limited amounts of fertilizer.

•If you must use pesticides, search for an environment-friendly brand.

•Recycle motor oil, paint, and other hazardous chemicals. Never dump such materials down the drain or into the storm system.

•Recycle glass, plastic, and aluminum.

•Always pick up your pet's waste or harmful bacteria can get into our water!

# **Environmental Advisory Council**

Malvern Borough is seeking applications from residents to serve on the newly established Environmental Advisory Council. There are seven (7) seats on this body. This body was established as an advisory board to Borough Council in 2019 through the adoption of Ordinance. #2019-10. Functions of this body include the following:

Advise the Borough Council, commissions, boards, Councils and other Borough agencies on, and promote education about, issues relating to the management, promotion, use, protection and conservation of the Borough's natural resources including air, land, and water resources, and residents' enjoyment thereof;

Work with the Borough's agencies and other partners to

maintain and develop the natural resources in the Borough in a way that will continue to attract and retain residents, visitors, and businesses without compromising ecological integrity;

Identify environmental problems and recommend plans and programs to the Borough Council;

Provide technical expertise on environmental aspects of subdivisions and land developments generally and providing environmental advice on specific projects or properties upon request of the Borough Council or the Borough Planning Commission; and

Recommend plans and programs, including proposed ordinances or amendments to the ordinances of the Borough, for the promotion and conservation of the natural resources of the Borough.

Individuals will be appointed to the following initial terms: two (2) members for two (2) years, two (2) members for three (3) years, and three (3) members for four (4) years. After the initial term, all members will be appointed to three (3) year terms.

# When Are You Vulnerable?

As winter is now fully upon us, are you prepared? Most of us have heard the "Preparedness Talk" ~ have a least three days worth of food and water, change the batteries in your smoke detectors, have an emergency kit in your car, etc., etc., etc. All great advice, and I actually continue to recommend it. However, every year, we seem to be surprised at the number of people who do not or cannot properly prepare for what may happen.

So this being my first winter as the Emergency Management Coordinator for Malvern Borough, I thought I would take a slightly different approach. While my advice is to still prepare with three days worth of sustenance, check your smoke detector, ensure you have medication, and have an emergency kit in your car, I am simply going to ask you the question, "When are you vulnerable?" Please note that I did not ask, "Are you comfortable?" Being vulnerable for the purpose of this article is when are you going to need help from Emergency Services, 911?

Since I have never understood the allure of camping, I will start with loss of electricity. While it can be frustrating, my concerns for the residents of Malvern are those who rely on electricity for their medical devices, at a great risk of being left in the dark, and for those without an alternate source for heat.



And I am sure there are more examples, which is my point . . . do you know when you are vulnerable if electricity is lost? And, in what timeframe could you become vulnerable? A few hours? A day? One Week? If temperatures are extreme?

If the power is off for more than three days, on the morning of Day 4, Malvern Borough has identified Malvern Retreat House as the Warming Center for residents. This is not a shelter since there are no sleeping or showering arrangements. Simply, a place to come, get warm, charge a device, and get information on resources you may need. The hours will be 10:00 a.m. – 4:00 p.m. and volunteers are needed. Please let me know if you can help.

An opportunity to discuss when are you vulnerable and how to prepare for an event will be held on Saturday, February 8, at 10:00 a.m. with Emergency Management Coordinator, Nora LoGiudice, at Borough Hall. Residents need to be prepared for three days of sheltering in place and know how to evacuate guickly. # **Planning Commission**

The Malvern Planning Commission (MPC) is a 'review and recommend' body of seven Borough residents who process Subdivision and Land Use (SALDO) applications, Zoning Hearing Board (ZHB) applications, monitor Zoning Ordinances, undertake Planning Initiatives, and provide comments on other Community Planning matters referred by Borough Council. The MPC's planning efforts are supported by the Assistant Borough Manager, Borough Engineers, and Borough Solicitors.

In the Fall quarter of 2019 the MPC completed review and recommend cycles for several ZHB applications and related sketch plans, including:

• a new Veterinary Hospital in the R-1 district at 545 South Warren Avenue, and • a two-lot subdivision in the R-2 district at 523 Monument Ave.

The MPC is now preparing to process SALDO applications for both:

- a newly designed Veterinary Hospital in the R-1 district at 545 South Warren Ave., and
- a two-lot subdivision in the R-2 district at 523 Monument Ave.

In 2020 we will continue working on a long-term Planning Initiative to revise definitions and processes for Zoning Ordinances related to Building and Lot coverage in Residential Zones. We are also in the early stages of a Planning Initiative - with Borough Management and Borough Council - for updating the Borough's basic planning documents: the Comprehensive Plan, the Zoning Ordinances, and the Official Map, in that order.

Current MPC members include Dave Knies, Chris Mongeau, Mark Niemiec, Geoff Rubino, Carroll Sinquett III (Chairperson), Warner and Zoe (Vice-Chairperson). Neil Lovekin the Assistant Borough Manager & Zoning Officer - serves as MPC Secretary. We continue to seek two additional Commissioners: a replacement for Malvern super-volunteer Lvnn Frederick and an alternate member.

The Malvern Planning Commission meets on the first and third Thursdays of each month, 7:30 PM at Borough Hall. Public participation is welcomed and encouraged! The status of various SALDO applications and initiatives can be viewed on the Borough website under Boards and Commissions/Planning Commission/ Case Log.

# Malvern Historical Commission

The Historical Commission wishes everyone in Malvern a Happy New Year and a successful 2020!

The Commission meets on the second and fourth Tuesdays of every month on the second floor of Borough Hall at 7:30 p.m. (Check www. malvern.org or the front door of Borough Hall for notices about possible meeting cancellations.) Feel free to attend our meetings,

either to volunteer to help out with the Commission's activities, to ask questions about the history of your property or about Borough history, or just to find out more about what's going on with regard to historical preservation in the Borough.

Other than our regular meetings, the next event where you can talk to members of the Commission will be Malvern Blooms. A date has not yet been set for this year's event, though it has customarily been held on the first Sunday in May from 11 a.m. to 4 p.m. Watch for future developments. Just a reminder: Awardees have expressed a concern that accepting a Preservation Award might somehow restrict their ability to use or renovate their home. That is not the case. The Preservation Awards merely recognize and commend those who have maintained their historical buildings in good condition. If you receive one, we would appreciate it if you help us publicize the Awards by displaying your plaque on the front of your building.



Although Award recipients are chosen solely by the Commission, we welcome questions, suggestions, and nominations from residents and members of the public. If you know of any older buildings in Malvern Borough that you think deserve a Preservation Award, please let us know.

# **Codes Enforcement Officer**

Over the years, residents have asked about the Code Enforcement process and why it appears that it takes a long time for a resolution to a Code issue. I'll try to describe the process here in an overview so that the public gains some idea of what can be an onerous and trying process. This is just an overview, the actual process can be quite involved and time consuming!

It either begins with a complaint from a resident or an observation by Code Enforcement. The information received is reviewed against the Borough's Codes to verify that a violation does exist. A letter is sent to the owner or occupant of the property explaining the issue, the code violated and a time to resolve it by. Most times, this is the all that needs to be done and the matter is taken care of. After a follow up, if the matter is not resolved additional notices are sent in an attempt to resolve the violation. If those notices are ignored, the property is posted with a copy of the sent notice(s) and time period by which the issue must be resolved.

Where these attempts do not result in a resolution to the matter, a Citation or Civil Action is filed with the local District Justice. Should the defendant plead guilty and remit the fine to the Court, the matter is closed, even though the violation remains. If the defendant requests a hearing, one is scheduled before the District Justice. If the outcome of this hearing is a guilty verdict, a fine is assessed only and the defendant has thirty days to appeal the verdict to Common Pleas Court. If the defendant doesn't appeal after the thirty days, the fine must be paid. For the Borough to have the violation resolved, an enforcement action must be filed in Common Pleas Court.

For an appeal at the Common Pleas level, the hearing process begins all over again and the previous fine is set aside. At this hearing, the Judge may uphold the District Court decision for the fine or overturn their decision. Again, it's only a fine, an enforcement action may still be required to compel compliance with the Codes.

This whole process can take a lot of time but sometimes, it's what the Code Enforcement Department is required to do as part of the enforcement process to gain compliance.

#### PAOLI BATTLEFIELD HISTORI-CAL PARK

A somber mist shrouded the Grounds as the tall, stately figure of General George Washington marches to lay a wreath on the grave of 52 of his Continental Soldiers who gave their lives in fierce hand-to-hand combat. These men sacrificed all so that generations to come would live in freedom. Portrayed by actor Dean Melissa, Washington led representatives of all U.S. military services, including the Coast Guard and Merchant Marines, and over 50 local citizens to lay individual wreaths along the stone wall surrounding the nation's second oldest Revolutionary War monument along with color guards, bugles and bagpipes. •AARP Cost = Free. Platform: iPhone and Android. This app provides a calendar of local events in your area as well as discounts that are available with your AARP membership.

•**Be My Eyes** Cost = Free. Platform: iPhone. This app illuminates magazines, newspapers and restaurant menus and magnifies them.

•Blood Pressure Monitor. Cost = Free. Platform: iPhone. Keeping track of your blood pressure is vital for many seniors. The Blood Pressure Monitor app allows you to track your blood pressure, weight and other vital statistics. You can also easily share them with your doctor. •OverDrive eBooks and Audio. Cost = Free. Platform: iPhone, iPad and Android. Borrow electronic books and audiobooks for free from your local library.

•Words with Friends Cost=Free. Platform: iPhone & Android. A fun game app similar to Scrabble. It allows players to challenge one another no matter where they live. It's a fun way to stay connected with loved ones while sharpening mental skills.
